The goal of Protect Kendall Now! is to utilize existing planning efforts and to collaborate
with public and private partners to increase the **pace** of land preservation in Kendall County.

If we all work together, we'll be able to preserve important natural areas.

Protect Kendall Now! Is...

- a vision for future open space and natural resources protection in Kendall County, developed through consensus
- organized by a Steering Committee consisting of local citizens and government representatives
- a local planning effort, driven by local citizens and elected officials
- a plan which depends on voluntary participation by landowners and developers for its implementation
- a network of natural resources compiled from adopted comprehensive plans into one countywide database
- a view incorporating lands with natural features identified by local citizen groups
- a collaborative public-private partnership
- **not** a zoning map
- **not** dictating future land use
- **not** an attempt to stop development
- **not** a private sector endeavor

This project is coordinated by The Conservation Foundation, a not-for-profit organization founded in 1972 and dedicated to preserving natural areas and watersheds. The Conservation Foundation's offices are located on a farm in unincorporated Will County, near Naperville.
